## Annual Report for the academic year 2013-14

Sultan-ul-Uloom College of Pharmacy has successfully completed **17 years** of academic excellence and is forging ahead in pursuit of multitudinous accomplishments. The focus had been on quality education and continuous improvisation. SUCP has continued to exhibit strong academic performance through the efforts of qualified faculty, trained supporting staff, need based capital investment on sophisticated lab equipments and above all the unflinching support by the Management of Sultan-ul-Uloom Education Society. The multidimensional efforts provide a strong momentum for a secure future in the competitive educational sector. Accordingly the following vision and mission statements were created that envisage our future goals and will be strictly adhered to.

### VISION:

Sultan-ul-Uloom College of Pharmacy aspires to emerge as an internationally acclaimed institute of excellence imparting holistic pharmacy education along with innovative research, industry interface and patient care with a humane touch.

### MISSION:

- Ensuring high standards in imparting education by well qualified and experienced faculty, effectively integrating critical thinking, problem solving, team spirit and leadership skills, thereby promoting the academic, entrepreneurial and career growth of the students with ethical values and social commitment.
- Providing well equipped library to quench intellectual thirst and laboratories to foster scientific temper for cutting edge research in pharmaceutical and clinical sciences that translates into health care and caters to the needs of the society at large.
- Building a collaborative environment with pharmaceutical companies, academic, clinical and research organizations that values and rewards innovation, productivity and life-long learning.

The academic year 2013-14 commenced with the introduction of two new Courses in M.Pharm. SUCP now offers the following courses:

**B.Pharm** (4 year course) with an intake of 60

**M.Pharm** (2 year course) **Four Specializations** with an intake of 18 each

- **Quality Assurance**
- **Pharmaceutical Chemistry**
- **Pharmacology**
- **Pharmaceutics**

With the constant support of the management and excellent guidance by the Honorary Secretary, our college applied for the following:

**1. Pharm D (Duration 6 years) and Pharm D Post Baccalaureate (3 years course after B.Pharm)**

To meet the statutory requirements for the above courses, SUCP entered in a MOU with Prime Hospitals, Ameerpet, accredited by National Accreditation Board for Hospitals (NABH).

**Status:** Completed Pharmacy Council of India inspection from 8<sup>th</sup> to 10<sup>th</sup> March, 2014 and awaiting the approval orders.

**2. National Board of Accreditation (NBA)**

**Through accreditation by NBA, the following main purposes will be served:**

- Support and advice to technical Institutions in the maintenance and enhancement of their quality of provision.
- Confidence and assurance on quality to various stakeholders including students.
- Assurance of the good standing of an Institution to government departments and other interested bodies.
- Enabling an Institution to state publicly that it has voluntarily accepted independent inspection and has satisfied all the requirements for satisfactory operation and maintenance of quality in education.

**Impact of Accreditation:**

The purpose and impact of accreditation goes far beyond quality assurance of an Institution/programme. Major impacts of accreditation system are summarized below.

- ✓ Encourages quality improvement initiatives by Institutions,
- ✓ Improves student enrollment both in terms of quality and quantity,
- ✓ Helps the Institution in securing necessary funds,
- ✓ Enhances employability of graduates,
- ✓ Facilitates transnational recognition of degrees and mobility of graduates and professionals,
- ✓ Motivates faculty to participate actively in academic and related Institutional/departmental activities,
- ✓ Helps create sound and challenging academic environment in the Institution, and
- ✓ Contributes to social and economic development of the country by producing high quality technical manpower.

**Status:** Paid the registration fee of Rs.5,61,800/- followed by application fee of Rs.1,12,360/- after which we got access for the SAR (Self Assessment Report). It is an exhaustive application that reflects our strengths in infrastructure, faculty and their achievements, academic performances, extracurricular activities, seminars, workshops, etc. The last date for submitting the application is 9.9.2014 but we intend to submit the filled form by 30.6.2014.

## **REGULATORY BODIES:**

**AICTE:** We submitted our application for Extension of Approval to AICTE for the academic year 2014-15 on 21<sup>st</sup> May, 2014.

**Pharmacy Council of India (PCI) :** SUCP had PCI approval from 2011-12 to 2013-14 and for the approvals from the academic year 2014-15, completed inspection in December, 2013 and awaiting the approval orders. We also completed PCI inspection in March 2014 for introduction of new course Pharm D and Pharm D PB and are awaiting their approval too.

**JNTU-H:** Another feather in the cap of SUCP is the **5 year Permanent Affiliation given by JNTU-H from the academic year 2014-15 to 2018-19**, making it the first pharmacy college under JNTU-H for this achievement. The good offices and guidance of the Hon. Secretary, Mr. Zafar Javeed, helped the institution in getting this. Besides, the entire **faculty including the Principal have been ratified by JNTU-H**, again the only pharmacy college to achieve this. Faculty profusely thanks our Hon. Secretary and Chairman, GC for their initiative and extensive co-operation in achieving these accomplishments.

## **MULTIDIMENSIONAL IMPROVISATION:**

The progress of an institution is determined by the improvement achieved in all aspects. Hence from 1<sup>st</sup> October, 2013, the following measures were immediately implemented.

### **1. Teaching-Learning Process:**

Teaching-Learning process is a dynamic activity that needs to be constantly upgraded, monitored and developed to face the current challenges effectively. The steps taken in this direction are:

- a) **Mentoring System** – Each class of B.Pharm is divided into 3 batches and each batch is assigned a faculty member as mentor who would periodically review and counsel the students in their academics, placements, participation in extracurricular activities and if required their personal problems too. Similarly one faculty member is assigned to each M.Pharm specialization.

- b) **Feedback** – Feed back is collected from students in every semester and is recorded for further improvement and relevant suggestions are effectively implemented.
- c) **Frequent Staff Meetings** – Teaching staff meetings are held at least once in a month to review the progress of various activities.
- d) **Faculty Development & Recruitment** – Two new faculty members were recruited as Assistant Professors. Faculty are constantly encouraged to associate themselves with professional bodies and attend seminars, workshops, faculty development programs to update their knowledge about the latest developments and advances in the pharmaceutical field. It is pertinent to mention here that SUCP has **6 faculty members with Ph.D** and **4 others are pursuing their Ph.D.**
- e) **Participation in Seminars / Workshops etc.** – Students under the guidance of faculty members are encouraged to participate in conferences, workshops etc., to broaden their intellectual horizons.

## **2. Modernization of Office activities:**

- a) **Office Automation Software by Future Web Technologies** – To get the information regarding the academic performance, fee details, etc., of a student at the click of a button. Before the commencement of next academic year, all the data entries of the current students will be completed. The cost of the software is Rs. 2,18,000/-
- b) **Alumni Registration Software by 100pins.com** – Well placed alumni directly reflects the strengths of an institution. This software is procured from 100pins.com at a cost of Rs. 26,629/- per annum. We are spreading the message to register to all our ex students and also the information goes to others when the students register and click on the facebook likes. Steps are being taken to register SUCP alumni association.
- c) **SMS Alert System by M/s. Maha Offers** - To send information to the parents regarding their ward's absenteeism and other vital information. This was purchased at the cost of Rs. 5,500/-.

## **3. Strengthening the Library:**

- a) **SOUL software for Library Automation** – Required for bar coding the books as the number of volumes is now 9271 and the number of books issued to each student has also increased. It becomes easy and quick for issue and return of books. It has been bought at a cost of Rs.60,513/-.

- b) **E-journals** – Access to 70 Science Direct international journals with back issues of last 4 years was renewed for the year 2014 at a cost of Rs.3,50,000/-.
- c) **Internet Facility** – Provided to students in the library and M.Pharm computer room.

#### 4. **Laboratories:**

Need based procurement of lab equipments are made. With the introduction of two new M.Pharm courses, equipment worth Rs. 5, 00,000/- were purchased after inviting quotations from suppliers. SUCP has 15 laboratories, machine room and CPCSEA approved animal house facility.

#### **FREQUENCY OF GC MEETINGS:** Total number of meetings in 2013 - **Three**

All the above achievements that the SUCP prides about would not have been possible without obtaining the right guidance from our untiring and ever encouraging Mr. Zafar Javeed, Hony. Secretary, Dr. Mir Akbar Ali Khan, Hon'ble Governing Council Chairman and Members. As per the directions of the Hon'ble GC Members, GC meetings shall be held at least once quarterly and if required more to ensure that quality education is provided at SUCP.
